



It is with a heavy heart that we share the news that Traveler's Medical Service LLC of Washington DC (Washington D.C. office) is closing as of December 31, 2021. The Covid-19 pandemic has had a lasting impact on the travel industry and on our travel clinic. This was an especially difficult decision as TMS DC was one of the first full-service private travel clinics in the United States and was founded by Dr. Martin Wolfe (my father and mentor) and his wife, Lotte Wolfe over 40 years ago. My wife and I were privileged to own and manage the practice during the 7 past years. We consider it an honor to have continued with their legacy of keeping patients safe, prepared and well-informed while traveling internationally.

**NY OFFICE: The New York practice remains OPEN.** They will continue to run their full-service travel clinic and maintain the website for TMS New York ([www.travelersmedical.com](http://www.travelersmedical.com)). **Please note that our New York office is an affiliate and does NOT have access to TMS DC records.**

**REQUESTING RECORDS PRIOR TO 12/31/21:** If you are a recent client of TMS DC and would like your vaccine records sent to a physical address (we cannot email records) please contact our office by December 30, 2021 by following these steps:

1. Send an email to [tmsdc1@gmail.com](mailto:tmsdc1@gmail.com)
2. Write: **Vaccine Record Request** in the subject line
3. Include **Patient Name, DOB and Physical Address** for USPS mailing in message body
4. Records will be sent in 7-10 business days

**REQUESTING RECORDS AFTER 12/31/21** The TMS DC practice officially closes on December 31<sup>st</sup>, 2021. After this time records from 2019, 2020 and 2021 will be transferred to Morgan Records Management, **TMS DC patients with records from 2019, 2020 or 2021 ONLY** can order a copy of their records from Morgan Records Management. Morgan Records Management, the records custodian, will continue to maintain your records in accordance with applicable confidentiality and security standards and with other applicable laws. Your records will be kept for at least 3 years per D.C. law. If you wish to have a copy of your records sent to you or to another provider or facility, you may submit a written request to Morgan Records early in the new year (effective date to be posted in the new year).
